Chief Dennis Allen has been an active member of the Evans Center Volunteer Fire Company for almost 40 years, having served as a fire department officer for most of his firefighting and EMS career.

Dennis responded twice to Ground Zero following the attacks of September 11, 2001 and helped shape the delivery of emergency

medical services in the Town of Evans. He served as the local representative to the Erie County Fire Advisory Board, as Code Enforcement Officer for the Towns of Evans and Hanover; and as an EMT-I for Rural Metro Medical Services.

Along with his wife Marlene and sons Scott and Marcus, this fire service leader has devoted his entire life to serving his community. Now he needs our help.

Denny is stricken with idiopathic pulmonary fibrosis and is on a waiting list for a double lung transplant at the Cleveland Clinic. The procedure requires the couple to relocate to the Cleveland area for up to three months following surgery.
